### **CONSIGNMENT AGREEMENT**

Consignor agrees to place the items listed below on consignment with Magers Enterprises, LLC to try to sell them under the terms of this agreement. Magers Enterprises, LLC agrees to accept the items listed for consignment sale under the terms of this agreement. Magers Enterprises, LLC provides the following services as part of the consignment service:

- Cleaning/detailing of the Firearm
- Appraisal of the firearm to determine selling price
- Detailed Photography
- Comprehensive Descriptions of Item in Ad Copy
- Answering Questions from Potential Bidders / Buyers
- All Shipping Charges
- Validating the Authenticity of Federal Firearms Licenses through the BATFE
- Licenses / Permits
- Storage of Firearms
- Collection of Payment
- Retention of All Documents Pertaining to Sale as Required by the BATFE

When the items consigned are sold and final payment is made by the buyer, the Consignor will receive their net amount by check within 30 days. The Consignor represents that they are the rightful owner of the items listed, and that the items are free of any encumbrance. The Consignor agrees that, as Magers Enterprises, LLC is required to complete all inspections and specifications, prepare the items for sale, and advertise the items, that the items consigned will be left on consignment with Magers Enterprises, LLC for a minimum of 60/90 days.

After 60/90 days, if not sold, consignor must pick up firearm or renew agreement in person within 15 days. After 15 days a \$2.00 per day storage fee will be assessed, NO EXCEPTIONS! While this agreement is in effect, Consignor agrees to grant the exclusive right to market and sell the items listed below to Magers Enterprises, LLC . If your firearm does not sell our charge is auction fees plus \$10.

ALL ITEMS MUST BE IN GOOD CONDITION AND CLEAN: Consignee reserves the right not to display any consigned item found on close inspection to be defective. Such items not reclaimed by the consignor within 15 days of notification, the firearm will become property of Magers Enterprises, LLC .

LIABILITY: Consignor hereby releases Consignee to the fullest extent possible from any and all claims or any nature in connection with or arising from the placement of Consignor's merchandise with Consignee. Consignor further covenants that he/she shall make no claim against Consignee or Consignee's insurance carrier for any damage to Consignor's merchandise.

If the Consignor decides to have consigned items returned, Federal Law requires that the Consignor complete all appropriate forms as if they were purchasing the firearms and pass the NICS background check and consignor agrees to pay Magers Enterprises, LLC the consignment fee. If consignor fails either the documentation or NICS check the firearm becomes the permanent property of Magers Enterprises, LLC .
